Dear Mr. C.:

At its hearings held on February 8, February 12, September 11, September 18 and October 1, 1996, the Trial Division of the University Tribunal considered the following charges against you:

- 1. In or about February 1995, you presented a test for remarking which you held out as the term test written in ECO200Y, but which in fact was a test written outside of the exam room and which contained forged marks, with the intent of forging or in another way altering or falsifying an academic record, contrary to Section B.I.3. (a) of the *University of Toronto Code of Behaviour on Academic Matters*.
- 2. In or about February 1995, you did use an unauthorized aid in an examination or term test or in connection with a term test or examination in that you re-wrote the February 7, 1995 term text in ECO200Y outside the exam room, and resubmitted the written text with a request that it be remarked, contrary to Section B.I.1(b) of the *University of Toronto Code of Behaviour on Academic Matters*.
- 3. In or about the first week of April 1995, you contacted Professor G. Hamilton and provided false information regarding the marks you received on the October 20, 1994 and December 1, 1994 term tests in ECO200Y, and thereby attempted, with intent, to forge, or in another way alter or falsify an academic record, contrary to Section B.I.3. (a) of the *University of Toronto Code of Behaviour on Academic Matters*.
- 4. On or about April 13, 1995, you presented two further tests dated October 20, 1994 and December 1, 1994, along with the test dated February 7, 1995, for remarking, which you held out as term tests written in ECO200Y, but which, in fact, were written outside of the exam room and which contained forged marks,

with the intent of forging or in another way altering or falsifying an academic record, contrary to Section B.I.3. (a) of the *University of Toronto Code of Behaviour on Academic Matters*.

5. In or about April 1995, you did use unauthorized aids in examinations or term tests or in connection with term tests or examinations in that you re-wrote the October 20, 1994 and December 1994 term tests in ECO200Y outside the exam room, and resubmitted the rewritten text with a request that it be remarked, contrary to Section B.I.1(b) of the *University of Toronto Code of Behaviour on Academic Matters*.

I am writing to formally advise you that the panel acquitted you of these charges.

Information concerning rights of appeal may be found in Section E of the *Code of Behaviour on Academic Matters* (copy enclosed). The deadline for filing an appeal by you or by the University is **October 31, 1996**.
