At its hearing held on June 22, 1998, the Trial Division of the University Tribunal considered the following charges against you:

THAT on or about May 26, 1997, you did knowingly engage in a form of cheating, academic dishonesty or misconduct, fraud or misrepresentation in order to obtain academic credit or other academic advantage of any kind, namely you submitted your paper entitled "The Second Industrial Revolution And The Staples Frontier in Canada: Rethinking Knowledge And History" in HPS 284S, which had been altered, contrary to Section B.I.3(b) of the <u>University of Toronto Code of Behaviour on Academic Matters</u>, 1995. Pursuant to Section B of the <u>Code</u>, you are deemed to have acted knowingly if you ought reasonably to have known that you engaged in a form of cheating, academic dishonesty or misconduct, fraud or misrepresentation in order to obtain academic credit or other academic advantage of any kind.

THAT on or about May 26, 1997, you did knowingly engage in a form of cheating, academic dishonesty or misconduct, fraud or misrepresentation in order to obtain academic credit or other academic advantage of any kind, namely you submitted your paper entitled "Political Design: Nuclear Reactors and National Policy in Postwar France" in HPS 284S, which had been altered, contrary to Section B.I.3(b) of the University of Toronto Code of Behaviour on Academic Matters, 1995. Pursuant to Section B of the Code, you are deemed to have acted knowingly if you ought reasonably to have known that you engaged in a form of cheating, academic dishonesty or misconduct, fraud or misrepresentation in order to obtain academic credit or other academic advantage of any kind.

THAT on or about May 26, 1997, you did knowingly engage in a form of cheating, academic dishonesty or misconduct, fraud or misrepresentation in order to obtain academic credit or other academic advantage of any kind, namely you submitted your paper entitled "Irving Langmuir and The Pursuit of Science and Technology in the Corporate Environment" in HPS 284S, which had been altered, contrary to Section B.I.3(b) of the University of Toronto Code of Behaviour on Academic Matters, 1995.

Pursuant to Section B of the <u>Code</u>, you are deemed to have acted knowingly if you ought reasonably to have known that you engaged in a form of cheating, academic dishonesty or misconduct, fraud or misrepresentation in order to obtain academic credit or other academic advantage of any kind.

The panel accepted your guilty plea and unanimously imposed the following sanctions:

- assignment of a failing grade in HPS 284S;
- a period of suspension from the University for each offence to run concurrently to January, 2000 (2.5 years from the date of the offence); and
- that the suspension and the reason for it be recorded on your academic record and transcript until you graduate from the University or for five years from the date of this decision, which ever should occur first.

Information concerning rights of appeal may be found in Section E of the <u>Code</u>. The deadline for filing an appeal by you or by the University is August 18, 1998.
